Keep in mind that the company rewards every month, the four most meaningful near misses / best practices.





Fire on the ship is one of the most dangerous situations that the crew can face and immediate actions must be taken by them to extinguish the fire.

On my Jaquar Max the emergency fire alarm was located behind the CITADEL steel door in the E/R when kept open.

In the event of an emergency, the emergency fire alarm could not be activated immediately.

Therefore, the crew decided to move to the side the Manual fire alarm so that it is accessible at all times, even when the Citadel Door is closed or open, so that it is not hidden. This provides smooth and easy access to anyone as it can be seen easily by the crew and activated faster. In this way, fire isolation can be achieved more efficiently.

### Getting the most from your Sleep

Ithough as a seaman you might not be in control of your shift patterns, there are some simple and straightforward techniques to help you get **the best** from your sleep. The most important thing is to **allow your body to learn a rhythm of sleep and wakefulness**. Developing good habits around sleep can help you tolerate the times when your sleep is disturbed by shifts or unavoidable disruptions.

### Prepare your cabin for sleep!

Our bodies are naturally aligned to wakefulness during the daylight hours and sleep during the hours of darkness. Using light and dark can help you to get a better sleep even if your shift patterns mean that you have to be alert during the normal night hours. When you want to be awake

and alert use bright lighting – daylight bulbs if they are available or open the curtains and let the sunlight in, during hours of daylight.

Life on board

Use blackout blinds or curtains in the period before and during sleep and dim the lighting in your cabin. If your cabin still isn't dark enough, try to prepare ahead and bring an eye mask with you on your next voyage. Do what you can to make sure your cabin is a relatively cool and comfortable temperature, is quiet and your bed is comfortable. There may need to be a ship policy of keeping quiet around the cabins for people who are trying to sleep during the day. If noise is a problem, you can try putting on soothing music, white noise or sounds of nature.

If you are worrying about problems at home or at sea, try writing them down
and putting them out of your mind before bed. Make time to address these
problems during the day, otherwise they will pop into your mind when you least
want them to.



Do not eat heavy or spicy foods in the few hours before going to bed.



· Have your last tea, coffee or energy drink several hours before you want to sleep.



Set an alarm at a regular time each day (if your shifts do not vary). Get up when
your alarm goes off, regardless of the amount of sleep you have had during the
night. This will help teach your body to develop a consistent rhythm.



If you do not work shifts, avoid taking naps during the daytime.




The following N/C was issued during an Internal ISM Audit: "Safety precautions were not followed when using welding equipment. The hoses were connected by re-usable worn drive clamps."

VIQ5.26: Is gas welding and burning equipment in good order and spare oxygen and acetylene cylinders stored apart in a well-ventilated location outside of the accommodation and engine room?

The guidance notes make reference to the British Compressed Gases Association Code of Practice CP7 for safe use of oxy-acetylene equipment. CP7 section 6.2 further states "Correct hose connections, properly fitted and tested to BS EN 1256 (43) and retained by suitable clips or ferrules, are essential. **Re-usable worm-drive clamps shall not be used.**"









## Lessons Learned: All Electric Wiring should be Kept Clean and Dry

arine Safety Forum released a Safety
Alert focusing on a case where during
routine maintenance onboard vessel,
crew discovered an exposed electrical cable.

#### The incident

The vessel's Electro Technical Officer was engaged in routine maintenance within a bridge storage locker and discovered an exposed electrical cable.

As explained, the cable was from a Fluorescent tube light which had been fitted in the locker, this cable was left uninsulated, which presented a potential for electrical shock and/or a fire hazard.

Wires are covered in casings that resist electricity, and when these casings fail, the exposed wire can cause damage to electronic devices. At best, devices will not get as much power as they should. The device may perform more slowly, and if a screen is involved, it might appear dimmer. At worst, damaged wiring may generate a power surge that can damage a device.

A tangled cobweb of cables, alongside a bare or damaged wire constitutes a danger. Not only is there a sever fire risk, but death from live electric wires is not uncommon.

#### **Lessons learned**

All Chief Engineering Officer's / E.T.O's should ensure that compartments, which are frequently opened, used for storage, have heavy human traffic, (such as on/off switches for equipment), or which have breakers within, that are often removed or switched off for isolation purposes, are checked for the condition of the cables. Outside electrical cabinets, which are more prone to wear, and tear should be checked on a regular basis.



The Following checks should be carried out as actions to prevent this sort of incident from happening:

- → Check all areas where wires meet other moving objects (i.e. Under bridge consoles)
- → Check all areas where wires connections are frequently adjusted (i.e. DP systems which are disconnected for trials etc.)
- → Check where there is heavy human traffic (i.e. Consoles with on / off switches, consoles where breakers are frequently being checked, changed out, or removed for isolation reasons
- → Areas which have had work recently done on them, adjustments, retrofits, etc.
- → Outside electrical compartments, which may be more suspectable to damage, wear, and tear.

"All electrical appliances should be firmly secured and served by permanent connections whenever possible. All electric wiring should be well maintained and kept clean and dry."

### Egypt's Suez Canal Blocked by Huge Container Ship



giant container ship the length of four football pitches was grounded and became wedged across Egypt's Suez Canal, blocking one of the world's busiest trade routes on March 23. Hundreds of vessels were stuck, waiting for specialist rescue teams to free the 400m-long ship, which was allegedly knocked off course by strong winds.

Egypt has reopened the canal's older channel to divert some traffic until the grounded ship can move again. The blockage sent oil prices climbing on international markets. About 12% of global trade passes through the Suez Canal, which connects the

Mediterranean to the Red Sea and provides the shortest sea link between Asia and Europe.

The Ever Given, registered in Panama, was bound for the port city of Rotterdam in the Netherlands from China and was passing northwards through the canal on its way to the Mediterranean. At 400m long and 59m wide, the ship has blocked the path of other vessels which were trapped in lines in both directions.

A fleet of tugs using cables or placing themselves directly alongside the stricken ship,

worked for many days to free it. As tugs struggled in their attempts to move the ship through the week, dredgers

were brought in to dig mud and sand from under the bow and stern of the ship. The combination of the tug boats and dredging equipment finally dislodged the ship 5 days later.

After days of being stranded, the backlog that had built up during the blockage stopped the Suez Canal Authority informed. Specifically, the last 61 ships, out of 422 ships that were queuing, passed through the canal on April 3.

What is more, an SCA investigation has also started to find out what caused the vessel to run aground in the canal and block the waterway for six days, the canal authority's chairman, Osama Rabie announced. According to Mr. Rabie, the investigation is not going to last long, and the results will be announced soon.

## Malaysian Ship Detentions by the Malaysian Maritime Enforcement Agency



alaysian law requires all vessels to notify Malaysia's Director of Marine for specific activities in Malaysian waters as specified in Malaysia Shipping Notice (MSN) 5/2014.

However MSN 5/2014 does not define the term "Malaysian waters", and the industry generally interprets "Malaysian waters" as Malaysia's territorial limit (i.e. 12nm).

Most recently, the common offences where ships are being detained in Malaysian waters include "anchoring without approval" and "ship-to-ship transfer of bunkers without approval". Since 2017, 176 ships have been charged with levied fines totalling RM11.48 million (approx. \$2.75m).

It is reported that since 24 March 2021, 31 ships have been detained by the MMEA under 'Operation Jangkar Haram' for failing to obtain the relevant permission to anchor in the eastern waters of Johor (South China Sea).

Under local law, Malaysian territorial waters are deemed to be 12 nautical miles offshore. However, it has been reported that the MMEA appears to be using territorial limits prescribed by a 1979 chart.


In the waters of Southern Johor, often inaccurately referred to as Singapore OPL East (which the MMEA does not recognise as a term), these territorial limits are as much as 60 nautical miles off the coast of mainland Malaysia, but are within 12 nautical miles of islands off East Johor claimed by Malaysia.

Accordingly, when a vessel waits at Singapore Eastern OPL, or Tompok Utara as the Malaysian authorities call it, prior approval of the MMEA must be obtained, failing which a vessel will offend section 491B of the MSO.

Should intend to anchor in the area, it is recommended Masters' familiarise themselves with the issues outlined above and give at least 24 hours' notice to the Director of Marine before any intended anchoring. If in doubt, consult your local agent or the club's P&I correspondent.



### FDA Stops Use of AstraZeneca

he Food and Drug Administration (FDA) has advised the Department of Health (DoH) to stop giving the AZD1222 vaccine of British-Swedish drugmaker AstraZeneca to persons below 60 years old. The recommendation comes after the European Medicines Agency (EMA) announced on Wednesday that it found "possible links" between the vaccine and blood clots in 16 cases across Europe. The EMA pointed out that the clots were a "very rare side effect" of the vaccine and that taking the vaccine remained beneficial.

FDA Director-General Rolando Enrique Domingo said the National Adverse Effects Following Immunization Committee has not received reports of possible platelet and thrombotic issues among those who had been inoculated with the vaccine in the country. However, Domingo said the FDA advised the Health department to restrict the use of the vaccine in light of the EMA warning. "We have asked the DoH that if there are remaining AstraZeneca vaccines, let's suspend its use on people below 60 years old so we can get clearer evidence and clearer guidelines from the WHO," Domingo said in a briefing on Thursday.

He added that those who took the first dose and did not experience any adverse reaction will be allowed to take the second dose. "If nothing happened after the first dose then there should be no problem on the second dose. This is very rare, but it will be included in the things to watch out for so we have to review the data and prepare before the next batch of vaccines come," Domingo told reporters in a Viber message. "I want to emphasize that this temporary suspension does not mean that the vaccine is unsafe or ineffective — it just means that we are taking precautionary measures to ensure the safety of every Filipino. We continue to underscore that the benefits of vaccination continue to outweigh the risks and we urge everyone to get vaccinated when it's their turn," he added.

The country expects to receive more than 900,000 doses of the AZD1222 vaccine through the Covax Facility in May as well as additional doses procured through the private sector in the third quarter of the year.



A number of nations have suspended the use of AstraZeneca's vaccine for younger populations after it was earlier banned outright in several places over blood clot scares.

The United Kingdom on Wednesday said it would adopt new medical advice to offer most people under 30 an alternative to AstraZeneca if possible after reporting 19 deaths from clots among people who received the shot. The EMA examined 86 blood clotting cases, 18 of which were fatal, out of around 25 million people in Europe who received the AstraZeneca vaccine. Most of the cases were in women aged under 60.

But EMA chief Emer Cooke said no particular risk factor had been identified and the clots might be linked to an immune response to the vaccine. "The benefits of the AstraZeneca vaccine in preventing Covid-19 overall outweigh the risk of side effects," she told a news conference. "It is saving lives."

The World Health Organization's vaccine experts on Wednesday echoed EMA's findings, saying a causal relationship between the vaccine and blood clots was "plausible but is not confirmed." AstraZeneca itself said two studies by British and European regulators "reaffirmed" that the benefits of its vaccine "far outweigh the risks."

Canada, France, Germany, Italy, Belgium, Spain and the Netherlands are among countries not recommending the shot for younger people.

### Fukushima: Japan announces it will dump contaminated water into sea



Japan has announced it will release more than 1m tonnes of contaminated water from the wrecked Fukushima nuclear power plant into the sea, a decision that has angered neighbouring countries, including China, and local fishers.

Work to release the diluted water will begin in about two years, the government said, with the entire process expected to take decades.

China denounced the plan as "extremely irresponsible", and accused Japan of reaching the decision "without regard for domestic and foreign doubts and opposition".

### Italy's Draghi accuses 'dictator' Erdogan, Turkey condemns the 'ugly' remarks



Italian Prime Minister Mario Draghi on Thursday (8 April) accused Turkish President Recep Tayyip Erdoğan of humiliating European Commission President Ursula von der Leyen this week and said it is important to be frank with "dictators", drawing condemnation from Ankara.

Von der Leyen and European Council President Charles Michel met Erdoğan in Ankara on Tuesday 6 April. The Commission chief was clearly taken aback when the two men sat on the only two chairs prepared, relegating her to an adjacent sofa.

"I absolutely do not agree with Erdoğan's behavior towards President von der Leyen. ... I think it was not appropriate behavior and I was very sorry for the humiliation von der Leyen had to suffer," Draghi told reporters.

"With these, let's call them what they are – dictators – with whom one nonetheless has to coordinate, one has to be frank when expressing different visions and opinions," he added.

Earlier on Thursday, Çavuşoğlu said that the seating at the meeting was arranged in line with the bloc's demands and international protocol and that Turkey was being subject to ugly and "unjust accusations".

### EU seeks clarification from J&J on delays in Covid-19 vaccines delivery



The company said it would delay the rollout of its vaccine in Europe and was reviewing with European health authorities cases of extremely rare blood clots in people after they received the shot.

European Commission is seeking clarification from Johnson & Johnson about its "completely unexpected" announcement of delays in deliveries of COVID-19 vaccines to the European Union, an EU official told Reuters on Tuesday.

The company had confirmed at a meeting on Friday that it would aim to deliver the contracted 55 million doses to the EU by the end of June, the official said.

J&J did not immediately reply to questions on whether the delay could affect delivery targets in the EU.
