e are pleased to announce that as part of the Company's tanker fleet renewal and expansion program, a contract has been signed with the South Korean Daehan Shipbuilding for 2 x 157,000t Crude Oil Tankers.

The two vessels with hull numbers 5095 and 5096 are scheduled for delivery in December 2024 and January 2025 respectively.

The vessels' optimized design and their systems, reflecting the latest develop-

M/V Furious Search & Rescue Operations



n 26/04/2023 at 18:00hrs LT and while the vessel m/v Furious was underway to Singapore, Captain Joel B. Loquias received a distress call through VHF radio from an Indian fishing boat with 10 crewmembers onboard, asking for assistance.

Vessel's name was "Lourdumatha" and as per the call she had suffered a Main Engine failure.

Master immediately notified the Company and upon verifying that the call was original, proceeded to the position Lat. 03-24.8'S, Long. 073-58.0'E in order to render assistance to the fishing vessel in distress.

M/V Furious arrived in the position of the fishing vessel a few hours later and commenced rescue operations, which were very difficult to complete due to very rough seas and 3.0 meters swell at the time.

In the early hours of 27 April 2023 rescue oper-

ations were completed and the 10 Indian fishermen had safely been embarked onboard the m/v Furious.

The fishing boat was abandoned in position Lat. 03-24.86'S, Long. 074-20.97'E and m/v Furious resumed her voyage informing also all concerned parties.

On 2 May 2023, the 10 fishermen were safely disembarked from the vessel off Indira Point and m/v Furious resumed her voyage to Singapore.

M/V Furious received a letter of appreciation by MRCC Mumbai for the swift effort and professionalism displayed, saving the lives of the 10 Indian fishermen.

We would also like to congratulate Captain Joel B. Loquias and all crew onboard m/v Furious for their professional conduct and good seamanship practice during this SAR operation!



Use the proper type of gloves for each task.


UNSAFE CONDITION



What happened: The Oiler was cutting a pipe using an electric rod cutter with a broken cutting wheel. This could result in the cutting wheel breaking, causing crew injury.

Make sure equipment used is in good condition. Replace defective items immediately.

What happened: The remote manual control for the deep fat fryer in the galley (wet chemical system) was concealed by various alerts and posters.

IMPORTANT REMINDER !

DANISH WATERS

Recently, a letter was issued from the Danish Maritime Authority (DMA) in respect of a fleet vessel which transited the Route "T" with a draught of 14.85m using the pilotage service only for a part of the Route "T".

Taking this opportunity we would like to remind you of the following:

According to the SN.1 Circular 263 of 23rd October 2007, re-section 1.9 and 1.14 in respect to navigation through the entrances to the Baltic Sea, the IMO recommends the use of pilotage from Skagen to Gedser and vice versa for ships with a draught of 11m or more following "Route T" on their voyage through the entrances to the Baltic Sea.

The Company emphasizes the need for careful navigation in the area in accordance with the International Regulations for Preventing Collisions at Sea and for use to be made of the reporting schemes.

To this respect:

• All Masters are recommended to use the pilot services by the coastal state on ship's passage through Danish Waters (from Gedser to Skagen and vice versa).

 Masters are instructed to use pilotage services whenever the maximum draught of the vessel exceeds the eleven (11) meters.

IMCA Safety Flash: Equipment Starts Unexpectedly

recent IMCA Safety Flash focuses on an incident in which, three engineers obtained a Lock-out/Tag-out (LOTO) for a High voltage AC unit, and were performing routine maintenance on the unit, to provide lessons learned.

The Incident

As one of them went to lubricate the bearings, the machine started unexpectedly. Work was stopped and a review was conducted. It was discovered that a linkage was broken in the circuit breaker handle and the breaker did not actually shut off when arranging the LO-TO. The plant electricians repaired the linkage, the LOTO was rehung, and the work was completed.

What went right and/or wrong?

- What went right: no one was in the line of fire when the machine restarted and there were no injuries;
- What went wrong: equipment failure – the linkage in the breaker handle was broken.

Lessons learned

- ✓ Carefully check that equipment is de-energized before working on it
 – prove that it is "dead";
- Ensure a full and thorough understanding of isolation and ensure the proper sources of energy are isolated when equipment is upgraded or modified.



IOGP (International Association of Oil & Gas Producers) Life-Saving Rules applicable

Energy Isolation: the engineers did not:

- Identify all energy sources;
- Confirm that hazardous energy sources were isolated, locked, and tagged;
- Check there was zero energy; did not test for residual or stored energy.


Work Authorisation: the engineers did not:

Confirm that hazards were controlled or that it was safe to start.

#2 Devote at least 5-10 minutes each day to meditation

#3 Take regular breaks to recharge

#4 Engage in meaningful hobbies that creatively challenge your brain

#5 Put your phone on silent and set boundaries when you log into social media

#6 Focus on getting enough quality sleep

#7 Take care of your physical well-being to feel more energized







Summary of Boarding and Attempted Boarding Incidents in the Singapore Strait (correct as at 1 Jun 2023)

Number of Incidents & Vessel Types



Key Observations and Assessments

- Of the three new incidents, one occurred in Phillip Channel, one occurred in Eastbound Lane of Traffic Separation Scheme (TSS), and one occurred in Westbound Lane of TSS. Of note, two incidents had items reported stolen (i.e. scrap metal, engine parts).
- Only one incident (22 May) reported perpetrators armed with knives. Of note, no confrontation and injury was reported in all of the incidents.
- All the incidents (involving different vessel types) occurred in hours of darkness (between 2330H to 0300H). IFC assesses that perpetrators will continue to conduct boarding when opportune, regardless of vessel types. Prompt reporting to local authorities is important to enable timely response.

Modus Operandi: Remains Largely Consistent With Petty Crime

- Based on incident reports this year, perpetrators mostly avoided confrontation, and fled immediately upon being sighted by crew.
- Perpetrators are usually unarmed, operating in group(s) of up to 5 pax using small boats to target slow-moving vessels (7-12 knots) with low freeboard (up to 6m).
- Bulk Carriers and Tankers Perpetrators may be armed (i.e. knives, and steel bars) and confrontation (out of 28 incidents since Jan 2023, 9 reported armed, and 2 reported with confrontation), and they usually target ships' engine parts and stores. Same group of perpetrators may target few vessels in succession, in same night.
- Tugs and Barges Perpetrators are usually unarmed, and target scrap metal. The vessel type could be targeted in both daylight and hours of darkness.

Recommended Actions for All Transiting Vessels

- Always remain vigilant, particularly when transiting known areas of concern in the Phillip Channel, and off Bintan and Batam.
- Adopt Ship Protection Measures recommended in the Regional Guide 2 to Counter Piracy and Armed Robbery Against Ships in Asia, e.g., (1) turn on weather deck lighting around the accommodation block and rear facing lighting on the poop deck, (2) maintain an all-round lookout at an elevated position with focus on suspicious small craft(s) approaching or in proximity to the ship's aft, and (3) sound ship's alarm when suspicious small craft(s) sighted.
- To guard against successive boarding attempts by perpetrators, transiting vessels are encouraged to stay informed by participating in Voluntary Community Reporting as depicted in 4th Edition MARSEC Charts Q6112 and Q6113. Upon sighting of suspicious activities or perpetrators onboard, immediately report to local authorities and inform the IFC; do not confront perpetrators.



King Charles III is crowned in once-in-ageneration ceremony



The family Britain's King Charles III has been crowned in a once-in-a-generation royal event witnessed by hundreds of high-profile guests inside Westminster Abbey, as well as tens of thousands of well-wishers who gathered in central London despite the rain. While Charles became King on the death of his mother, Queen Elizabeth II last September, the coronation was the formal crowning of the monarch.

The service was a profoundly religious affair, reflecting the fact that aside from being head of state of the United Kingdom and 14 other countries, Charles is also the Supreme Governor of the Church of England.

The intricate service lasted just over two hours – about an hour shorter than Elizabeth II's coronation in 1953 – and followed a traditional template that has stayed much the same for more than 1,000 years.

The King took the Coronation Oath and became the first monarch to pray aloud at his coronation. In his prayer he asked to "be a blessing" to people "of every faith and conviction."

Tina Turner: Music legend dies at 83

Singer Tina Turner, whose soul classics and pop hits like The Best and What's Love Got to Do With It made her a superstar, has died at the age of 83.

Turner had suffered a number of health issues in recent years including cancer, a stroke and kidney failure.

She rose to fame alongside husband lke in the 1960s with songs including Proud Mary and River Deep, Mountain High. Dubbed the Queen of Rock 'n' Roll, Tina Turner was famed for her raunchy and energetic stage performances and husky, powerful vocals.



Her death was announced on her official Instagram page.

"With her music and her boundless passion for life, she enchanted millions of fans around the world and inspired the stars of tomorrow," the post said. "Today we say goodbye to a dear friend who leaves us all her greatest work: her music."

Sweden's Loreen wins historic second Eurovision, after emotional show in Britain



Sweden's Loreen has won the Eurovision Song Contest for a second time, earning a historic triumph at an extravagant and crowd-pleasing show held in Liverpool, United Kingdom, on behalf of Ukraine.

She became just the second performer to win the competition more than once, clinching victory with pop ballad "Tattoo" and cementing her legacy at the wildly celebrated music contest.


Loreen had previously won the contest in Baku in 2012, with her career-altering hit "Euphoria." Her latest win means Sweden ties Ireland for the most victories in the competition, with seven – and it came 50 years after ABBA won with "Waterloo," the moment that shot them to superstandom.

Global warming set to break key 1.5C limit for first time

Our overheating world is likely to break a key temperature limit for the first time over the next few years, scientists predict. Researchers say there's now a 66% chance we will pass the 1.5C global warming threshold between now and 2027.

The chances are rising due to emissions from human activities and a likely El Niño weather pattern later this year.



If the world passes the limit, scientists stress the breach, while worrying, will likely be temporary.

Hitting the threshold would mean the world is 1.5C warmer than it was during the second half of the 19th Century, before fossil fuel emissions from industrialisation really began to ramp up. And breaking the limit even for just one year is a worrying sign that warming is accelerating and not slowing down.

The 1.5C figure has become a symbol of global climate change negotiations. Countries agreed to "pursue efforts" to limit global temperature rises to 1.5C under the 2015 Paris agreement.

Going over 1.5C every year for a decade or two would see far greater impacts of warming, such as longer heatwaves, more intense storms and wildfires.

But passing the level in one of the next few years would not mean that the Paris limit had been broken. Scientists say there is still time to restrict global warming by cutting emissions sharply.

Neuralink: Elon Musk's brain chip firm says US approval won for human study

Elon Musk's brain-chip firm says it has received approval from the US Food and Drugs Administration (FDA) to conduct its first tests on humans.



The billionaire's Neuralink implant company wants to help restore people's vision and mobility by connecting brains with computers.

It says it does not have immediate plans to start recruiting participants. Mr Musk's previous ambitions to begin tests came to nothing.

The regulator itself is yet to comment.

An earlier bid by Neuralink to win FDA approval was rejected on safety grounds, according to a report in March by the Reuters news agency that cited multiple current and former employees.

Neuralink hopes to use its microchips to treat conditions such as paralysis and blindness, and to help certain disabled people use computers and mobile technology.

The chips - which have been tested in monkeys are designed to interpret signals produced in the brain and relay information to devices via Bluetooth.

Mr Musk has also previously suggested that the proposed technology could help ease concerns about humans being displaced by Al.

Announcing Thursday's news on Twitter, Neuralink talked of an "important first step that will one day allow our technology to help many people".
