Any seafarer not complying with the Company's D &A Policy shall be immediately dismissed and will be considered non-rehireable.

Steel Cutting of HN 5095 tbn Energy Delos on 01 April 2024

n May 30, 2024, a group of ESTSA Supts. from Technical Department visited the Techcross Training Center to participate in specialized training on the ECS (Electro-Cleen System) Ballast Water Treatment System. This visit aimed to enhance their understanding with the ECS, a leading technology in ballast water management systems.

The ECS is an innovative BWMS that employs direct electrolysis technology to

treat ballast water. The ECS operates by passing incoming seawater through an Electro-Cleen Unit (ECU), where it undergoes sterilization via direct electric processes. This method effectively eliminates harmful microorganisms. The treated seawater is then stored in the vessel's ballast tank, with residual hypochlorite acid ensuring the prevention of microorganism regrowth.

During the deballasting process, the remaining Total Residual Oxidants (TRO) in the treated water are neutralized to mitigate environmental impact. Unlike the ballasting process, the seawater is directly discharged without re-passing through the ECU, making the system efficient and environmentally friendly.

Dynamic Striker Recognized for Responsibility in Whale Protection

e are proud to announce that our vessel, M/V Dynamic Striker, has been recognized by the National Oceanic and Atmospheric Administration (NOAA) for its compliance with speed restrictions while transiting the Stellwagen Bank National Marine Sanctuary, an area crucial for the protection of endangered North Atlantic Right Whales.

These restrictions are in effect from January 1 to May 15 and March 1 to April 30 annually and aim to reduce ship collisions with these whales.

The acknowledgment, based on data from the United States Coast Guard's Automatic Identification System (AIS), highlights vessel's adherence to the 10-knot speed limit, reflecting our commitment to maritime safety and environmental conservation.

HAZARD

A HAZARD is something that has the potential

RISK

Hazard:

No labels to indicate the cylinders' fill status inside Oxygen and Acetylene Room.

Risk:

Without clear labels, crewmembers might mishandle cylinders, assuming they are empty when they are full or vice versa.

Best Practice:

Labels indicating the presence of gases have been installed on all cylinders to ensure quick and accurate replacement.

Hazard: Rudder color indicators (red for port, green for starboard) are missing. Risk:

Navigation confusion leading to accidents and potential finding during 3rd party inspections.

Best Practice:

Steering gear rudder has been marked with red and green colors.

Hazard:

Not enough space in the CCR to accommodate the jackets, shoes, and helmets of the Officers.

> Risk: Disorder in CCR.

Best Practice:

Additional coat pegs have been installed to enhance organization and order.

UNSAFE ACT

UNSAFE CONDITION

What happened:

During the safety routine inspection, it was observed that the Lifeboat helms-

man window was not clear.

In an emergency, impaired visibility can delay response times and increase the risk of accidents or collisions, compromising the safety of all crewmembers.




What happened:

An engine crew member was carrying two bags of garbage up the ladder to the garbage store with both hands, while the ship was in rough seas.

Always ensure to

hold onto the ladder with one hand while carrying items to keep your balance especially during adverse weather conditions.

UNSAFE CONDITION





What happened:

During inspection on deck, it was found that access to the helicopter equipment is obstructed, impeding fast access.

This blockage could pose significant delay in the event of an emergency or during regular helicopter operations.

What happened:

During a routine inspection, it was found that the box containing Fire Equipment and Breathing Apparatus was covered by safety harnesses.

Ensure that fire equipment and breathing apparatus are always easily accessible so that they can be used in case of an emergency.



UNSAFE ACT ailure to use PPE properly



What happened:

While working aloft, the crewmember used all required PPE, however, he did not properly secure the safety harness to a strong point. Always ensure to properly secure the safety harness when working aloft.

UNSAFE CONDITION neffective Fire Suppressior



What happened: Pallets were not stacked correctly, and nails were protruding from one of the pallets.

UNSAFE CONDITION

Before leaving an area after completing a task, verify that everything is properly arranged and in its correct place.

UNSAFE CONDITION otential Rightship Finding



What happened: The connections and fittings of the CO2 bottle were found not properly tightened.

If the CO2 system does not function correctly due to loose connections, it will be unable to effectively suppress or extinguish a fire.



What happened: During E/R inspection, it was found that the insulation mats around the starter and distribution panels, were not of an approved type, and no certification was available for those mats.

All such insulation mats should be in accordance with international standards, stamped and/or certified and be able to withstand the maximum voltage onboard (which is AC 440V)



BEST PRACTICE

What happened:

During the fire drill, it was discovered that the ventilation latches were positioned too high and there were no steps or handles for quick closing.

Inability to quickly close the ventilation latches during an emergency.

An additional step and handle were installed to quickly and easily close the ventilation.

UNSAFE CONDITION Exposure to Fumes/Fire Hazard

What happened:

Tins of paint were left open inside the paint locker.

Open paint tins can release harmful

fumes, posing health risks such as respiratory problems. Additionally, they present a fire hazard due to the potential accumulation of flammable vapors.

IMPORTANT REMINDER !

Tokyo and Paris MOU CIC on Crew Wages and SEA from 1 September to 30 November 2024

We remind you that a Concentrated Inspection Campaign (CIC) focused on Crew Wages and Seafarer Employment Agreements will be conducted from <u>September 1 to November 30, 2024</u>, in the regions covered by the Tokyo Memorandum of Understanding (MOU) and the Paris MOU.

During this period, each ship will undergo a single inspection as part of this CIC, which will be performed with the normal PSC inspection.

Inspection Focus: Port State Control Officers will use a predefined questionnaire to assess that crew wages, seafarers' employment agreements (SEAs) and financial securities provided comply with the relevant MLC requirements.

Upon completion of the CIC, ensure that a copy of the PSC inspection report (Forms A and B) and the completed CIC questionnaire are retained onboard for record-keeping purposes.

Lessons Learned: Emergency Drill and Fire Safety

essons learned from two incidents relating to emergency drills and musters.

Incident 1 – Emergency button stuck

During an emergency drill, it was found that the General Emergency alarm on the bridge was delayed whilst being activated.

Further investigation revealed that the dedicated Emergency button was stuck, and it failed to perform its function in a timely way.

Lessons learned

Check: could your emergency alarm buttons be stuck or seized? When was the last time anyone actually pressed the fire alarm button?

Incident 2 – Near Miss – Smoke at muster station

A fire alarm was set off on the port side muster station where there was a smoking area. An AB and the 2nd Mate were sent to investigate what was going on. On arrival at the muster station there was dense smoke coming from the ashtray stand. The ashtray was opened, and a smouldering paper cup was found, along with recently discarded cigarette butts.

The smoker had, instead of bringing the cup to the dedicated waste bin which was 10 metres



away, just opened the standing ashtray and dumped the paper cup together with the still burning cigarette butt and closed it. This action caused smouldering and a small fire and could have developed into a much more serious situation.

What went wrong

- Personal negligence and not following basic rules;
- In other circumstances and conditions such negligence could have led to a more serious fire.















Celine Dion dazzles Olympics after four-year health absence



Celine Dion has returned to the stage for the first time since revealing a serious health condition, delivering a typical powerhouse performance at the Paris Olympics opening ceremony.

The Canadian superstar had been rumored to be singing a duet with Lady Gaga, but instead went solo on the Eiffel Tower to bring the four-hour event to a stirring climax.

It was Dion's first live performance in four years, and came a year and a half after she revealed a diagnosis of Stiff Person Syndrome (SPS).

Duplantis breaks pole vault world record on way to gold



Sweden's Armand Duplantis set a new world record of 6.25m after winning gold in the men's pole vault. The 24-year-old, who had secured successive Olympic titles by clearing six metres, set an Olympic record of 6.10m with his next attempt.

The two-time world champion has now broken the record on nine occasions.

Zheng, 11, becomes China's youngest Olympian

An 11-year-old who was born on the penultimate

day of the London 2012 Olympics has become China's youngest Olympian. Zheng Haohao was among the competitors in the wom-



en's skateboarding park in Paris.

Zheng scored a best of 63.19 to finish 18th in the preliminary round - missing out on a final that was won by Australia's Arisa Trew, 14.

Having only taken up skateboarding at the age of seven, she leaves France as one of the youngest Olympians of all time.

Andy Murray says goodbye to tennis, like only he can



When Andy Murray announced he would retire from professional tennis after the Paris Olympics, the script seemed to be set. The three-time grand slam could bow out of his incredible career with yet another Olympic gold, in a tournament that has meant so much to him throughout the years. But, as it turned out, medals were not necessary for Murray to say the perfect goodbye.

After losing in straight sets to American's Taylor Fritz and Tommy Paul on Thursday, Murray and his British teammate Dan Evans shared an emotional embrace on court. Despite not winning a medal, the pair had written one of the best stories of this year's Games, twice producing logic-defying comebacks to even make it to the quarterfinal of the men's doubles tournament.

Spain Wins Euro 2024, Defeating England 2-1 in a Dramatic Final to Claim Record Fourth European Championship

pain won a recordbreaking fourth European Championship, defeating England 2-1 following a drama-filled second half in the Euro 2024 final on Sunday in Berlin.

Nico Williams - one of Spain's breakout performers at the tournament – gave La Roja the lead minutes into the second half when he smartly finished in the bottom corner from a perfectlyweighted pass from the team's other emerging star, freshly turned 17-yearold Lamine Yamal.

England equalized midway through the second half



through a brilliantly placed left-footed effort from Cole Palmer from outside the box to restore parity at the Olympiastadion in the German capital.

But with just under five minutes remaining in regulation time, Spain took a late lead when Mikel Oyarzabal tapped home an inch-perfect pass from Marc Cucurella to cap off a victory and a terrific tournament for La Roja.

It is Spain's fourth Euro title – having previously won in 1964, 2008 and 2012 – while for England, it is heartbreak for a second straight European Championship having been beaten by Italy on penalties at Euro 2020.

Argentina Win Record 16th Copa America in Match Marred by **Crowd** Chaos

rgentina have lifted their 16th Copa America title, with their biggest star Lionel Messi likely bidding farewell to international football. The game in the US city of Miami, which was delayed by more than an hour after thousands of fans without tickets tried to enter the stadium, was a cagey affair for more than 90 minutes but opened up in the extra period.

Lautaro Martinez, the tournament's leading scorer, latched onto a precise through ball from Giovani Lo Celso before lifting his effort over advancing Colombia



goalkeeper Camilo Vargas in the 112th minute to spark wild celebrations among Argentina fans. Just inside the penalty area, Martinez sent a right-foot shot through the upraised arms of sliding goalkeeper Camilo Vargas for his 29th international goal, his tournament-high fifth.

Argentina's latest title, their 16th Copa win, comes on the back of their triumphs at the 2022 World Cup and 2021 Copa America and gives eight-times Ballon d'Or winner Messi the perfect sendoff in what could be his last international tournament.

Novak Djokovic beat Carlos Alcaraz in thrilling fashion to secure a longawaited Olympic title and complete the career 'Golden Slam'. Djokovic, who has won a

men's record 24 majors and swept up every title there is in tennis, finally clinched Olympic gold at his fifth Games.

The Serb, 37, put in his best performance of the year to beat French Open and Wimbledon champion Alcaraz 7-6 (7-3) 7-6 (7-2) in front of a packed crowd in Paris. He sealed the title with a forehand winner, then



turned towards his box - arms outstretched in disbelief - before throwing his racquet to the floor after a draining match which lasted just under three hours.

After hugging Spain's Alcaraz, Djokovic immediately burst into tears and fell to his knees in the middle of the court. He then unfurled a Serbian flag and clambered into the stands to celebrate with his family and support team. Djokovic is just the fifth player to win the 'Golden Slam' in singles - all four majors and the Olympic title - after Rafael Nadal, Serena Williams, Andre Agassi and Steffi Graf.

Simone Biles Didn't Finish With Gold, But the Paris Games Still Belonged to Her

rtistic gymnastics at the Paris Olympic Games came to a dramatic end Monday, as Simone Biles won the silver medal in the floor exercise final.

She won her 11th Olympic medal and seventh gold in Paris, leaving her within striking range of Soviet legend Larisa Latynina's nine golds, the most of any gymnast. Brazil's Rebeca Andrade bested Biles for the floor gold, becoming the nation's most decorated Olympian. In one of the most dramatic twists of the Games, Jordan Chiles won her first individual Olympic medal after appealing her score, adding a floor bronze to her two team medals: a Paris gold and a silver in Tokyo.

"Obviously, it wasn't my best performance," Biles said after the meet. "But at the end of the day, whoever medaled medaled, and that's what's so exciting, because you just never know, it's gymnastics."

Chinese gymnast Yang Liu secured the gold medal with a score of 15.300, while his compatriot Zou Jingyuan took silver with a score of 15.233.Petrounias' medal marks Greece's fifth in the Paris Olympics .

Julien Alfred's Historic Gold Win for Saint Lucia

s Julien Alfred powered past the finish line, the new Paris 2024 women's 100m Olympic champion screamed with joy and pointed to the crowd before bursting into tears.

In the blink of an eye, the three-time NCAA champion had pulled off a stunning victory in the Stade de France, beating pre-race favourite Sha'Carri Richardson to gold in 10.72 seconds and giving Saint Lucia its first Olympic medal in the history of the Games.
